Bringing Sunshine to the Lives of Patients & Families

The Benefits of Hospice Care Early in an Illness

"She was funny without trying to be funny," shared Matt Calderone, when describing his wife, Lisa. She enjoyed traveling to the beach and Disney World. When she wasn't working as an early intervention coordinator for toddlers and children, Lisa would enjoy watching afternoon soap operas. "I work from home so I would often watch soap operas with Lisa," smiled Matt. But most of all, Lisa enjoyed spending time with their daughter, Maddie. "Lisa's entire world revolved around Maddie," commented Matt. "On September 4, 2019, cancer lost its battle with Lisa. Cancer was

never able to steal her smile, and it was never able to overcome her spirit. Lisa never allowed it to quiet her laughter. Every day she was given was lived to the fullest. She may not be here anymore but one day we will be reunited. Lisa has won and cancer has lost, and Hospice & Community Care made that possible."

Providing Support

Making the decision to begin hospice care is never easy. Like many people, Matt and Lisa viewed hospice as a place where people go to die. Lisa was cared for by Hospice & Community

Care for a year and a half. "Before we called Hospice, I was caring for Lisa by myself," commented Matt. "I had no one to lean on." That all changed when Hospice & Community Care got involved. "Hospice allowed us to be a family again. It allowed me to step back as a caregiver and to be a husband." Matt had been serving as Lisa's primary caregiver for eight years.

"The support that Lisa and our family received from Hospice staff was incredible," expressed Matt. The Calderones' had the support of the organization's team of physicians, nurses, aides, social workers,

chaplains, massage and music therapists, and volunteers. Matt was no longer caregiving alone.

“Before hospice care started I was making multiple trips weekly to pick up Lisa’s medications,” commented Matt. “When Hospice began, they immediately made arrangements for Lisa’s medications to be delivered to our home, which was a blessing. If I had an issue, a nurse was available to offer guidance. Hospice was there to provide help and make life a lot easier.”

The Hospice & Community Care team also supported Maddie. “Justine and Tara [Hospice & Community Care employees] would talk to Maddie often about Lisa and her cancer diagnosis,” shared Matt. “I don’t know what they talked about nor did I need to know. As long as they were helping Maddie that was all that mattered.” Lisa and Matt were always forthcoming and honest with Maddie about Lisa’s health and the likelihood that Lisa would die. Maddie was two years old when Lisa was diagnosed with cancer. “Maddie lived with Lisa’s cancer,” commented Matt. “Maddie has a great support system,” according to Matt. She participates in dance and her “dance family” has really taken her under their wing. “Maddie is doing really well,” shared Matt. “I know that there will be moments in her life when she is hurting. She will always have me and others to lean on for support.”

Finding What is Sacred

At any stage of an illness, Hospice & Community Care team members work with patients and families to help identify what they want to do, and honor their hopes and wishes, before they die. For Lisa, one of her greatest wishes was to die at home where she felt most comfortable. She also wanted to make lasting memories for and with her family.

With the assistance of Hospice social workers, Lisa wrote cards for Maddie to open at milestone events, such as her birthday, graduation and wedding day. “I had the pleasure of helping Lisa write notes to Maddie,” shared Justine Marich, Social Worker, Hospice & Community Care. “Lisa and I would discuss what to include in the notes, such as what she would tell her 16-year-old self and life lessons on dating. Lisa was legacy building. Lisa and I formed a strong connection

during our time together. I will always cherish those moments.”

Maddie turned 12 years old in January 2022 and received one of her many notes from Lisa. “Maddie looks forward to getting the notes,” said Matt. “She keeps the notes to herself—as they are something special that she holds near and dear to her heart.”

The song *You Are My Sunshine* was very important to Lisa—as Maddie was her sunshine. Lisa worked with a videographer to record a CD of Lisa singing *You Are My Sunshine*, along with other songs that have special meaning between mother and daughter.

Lisa did not let her illness hold her back from her love of traveling. The Calderones’ went to Disney World and the Outer Banks—even parasailing together as a family. “Our team worked with hospice providers in Florida and North Carolina to make sure that Lisa would be safe and comfortable on her travels in case assistance was needed,” commented Justine. “We helped with documentation so that Lisa could take her medications through airport security and we helped secure transportation for the family throughout the Disney Parks. I love being able to help families, like the Calderones’, create memories and make the most of their time together.”

Living Life to the Fullest

After a trip to the hospital in August 2019, Lisa and Matt decided it was time to stop her cancer treatments. Lisa had been using TPN (total parenteral nutrition), an artificial nutrition IV, for years and her physician told her that stopping the IV treatment would make her tired and pass away peacefully. “Lisa always worried that it would be painful to die,” shared Matt. Lisa’s physician estimated that she would live for a week or two after ending treatments. Hospice & Community Care helped Lisa stop all of her medications and managed her comfort. Lisa lived for six weeks.

“Before those six weeks, Lisa slept for 14–16 hours a day to save her energy to attend Maddie’s dance recital, school events or visit with family and friends,” shared Matt. “During the last six weeks of her life, Lisa was more alive than she was in the last year and a half. We had visitors coming to our house at all hours of the day and we would laugh, cry and tell stories with Lisa. Nothing was left



unsaid and Lisa had closure before she passed. Hospice & Community Care allowed us to do that.”

“In Lisa’s final weeks, Hospice staff were at our home a lot,” shared Matt. “They would answer any questions that family and friends had while they were visiting with Lisa and they never made people feel rushed. The Hospice team gave us the opportunity to mourn and enjoy the last six weeks of Lisa’s life.” 🌸



Finding Strength through Grief

Giving back to those in need

"Take the chance," shared Jude Gemmell. "Grief support is so helpful. When you are grieving the loss of a loved one you think that you are the only one who has ever felt that way. But grief is a common human experience. I cannot imagine where I would be now without the support of my family, friends and the Pathways Center for Grief & Loss. I would definitely not be where I am today."

Jude first used the services of the Pathways Center for Grief & Loss after her husband died. "My husband, Larry, died at the age of 64 in 2014," shared Jude. "It was also four months after I had retired from a 30-year career as a school counselor. I was going through big changes in my life and knew I needed support." Jude had been Larry's primary caregiver for 14 years.

The Pathways Center for Grief & Loss is a free resource to the community, regardless of whether a loved one is or was a hospice patient. The Pathways Center specializes in helping people cope with serious illness or loss after death. The generous support of the community allows Hospice & Community Care to offer its grief programs and services at no cost.

Jude participated in the Pathways Center's Newly Bereaved program, a three-week series that provided her with an overview of common grief responses and helped her to begin to

identify coping tools. She attended the Growing Through Grief six-week series where she explored how she has been impacted by her loss, who she was apart from Larry, and how she could continue to reorganize her life. Pathways Center bereavement counselors also provided Jude with one-on-one support.

While Jude was reeling with the death of Larry, eight months later she would begin another long journey of

caregiving for her mother, Vada. Jude cared for Vada in her home after Vada fell and broke both femurs. "There were many ups and downs when caring for my mother," shared Jude. Vada would eventually move back to her home for a short period of time, later moving to an assisted living facility where she received personal care followed by skilled care. Vada passed away in 2019 under the care of Hospice & Community Care.

Virtual Caregiver Support Group

Third Thursday

Hear from others whose loved one is receiving hospice care, while sharing your experience with others who may understand. The Caregiver support group is facilitated by a Master's level counselor and volunteer who has been a caregiver. Topics of discussion may include managing anxiety, guilt or anger; communicating your needs to others; and caring for you.

"When I was caring for Larry I wanted to talk to other caregivers," shared Jude. "It is hard being a caregiver and this group will give you the tools and connections to take care of your loved one while taking care of yourself."

Following the death of her mother, Jude sought the support once again of the Pathways Center. "My relationship with my mother was different than my relationship with Larry," commented Jude. "The skills and training that I learned while grieving for Larry helped me while mourning the loss of my mother, however, it was still important for me to connect with others who were experiencing the same type of loss."


"I was so grateful for the support that the Pathways Center gave me during the loss of Larry, that I wanted to find a way to give back to others," shared Jude. In 2016, Jude went through Hospice & Community Care's volunteer training. She would visit with patients in senior living facilities and represent the organization at community events, but her true passion was giving back to caregivers and bereaved individuals.

Jude co-facilitated the Pathways Center's Growing Through Grief series, and she now assists with the new Caregiver support group and Loss of a Parent support group.

"It is rewarding to see when people are able to slowly move through their grief," shared Jude. "There is a point in grief where you feel like you will never feel better. As a co-facilitator of the Growing Through Grief group, I saw a real difference in people over the six-week series. Something that I personally experienced, too. You know that your life is never going to be the same. Life will be good again, but good in a different way."

Jude also has the support of her family and friends. "I am fortunate to have the best of everything," shared Jude. "I am close to my daughters, sons-in-law, grandchildren and friends. I encourage anyone who is hurting to access what people are trying to give you. Never be embarrassed to ask for help."

Community Fundraisers Make a Meaningful Difference

Our community is home to many generous organizations and individuals that support area nonprofit organizations, like Hospice & Community Care. This is shown through volunteerism, donations of items and financial support. In 2021 more than \$109,000 was raised, translating into 569 days of hospice care for those in need. Individual Support Todd and Melissa Auker



People helping people. That is how Todd and Melissa Auker describe the all-day fundraiser that they host annually for Hospice & Community Care. They even print it on t-shirts to raise additional money. Now in its 16th year, the event includes local bands, a chance auction and cash raffle. Invited guests bring covered dishes to share, as well. “The support that the Aukers receive is amazing,” shared Amy Lewis, Director of Philanthropy, Hospice & Community Care. “I have had the pleasure of attending the event and it is inspiring to see friends, families and local businesses coming together to help people who are coping with a life-limiting illness or loss. Many of the attendees have been touched personally by Hospice & Community Care.”

The Aukers have raised nearly \$250,000 since they started their event in 2006 and brought in a record \$42,000 last year! To raise those large sums, they make it a family affair with

their children pitching in to set up, sell raffle tickets, collect donations, and help with clean-up. When asked why they do this for Hospice & Community Care, the Aukers said, “It’s just the right thing to do.”

Association Support Lancaster Senior Men’s Golf Association (LSMGA)

“We and our families have been touched in some way by Hospice & Community Care,” shared Randy Shue, President, LSMGA, which has held a fundraising tournament to benefit Hospice & Community Care for over a decade. “Initially the event was open to the public, but as the league grew from 40 members to more than 140 it has become a league members’ only event,” commented Mike Riley, Treasurer/Historian, LSMGA. Since 2011 the league has donated \$89,400 to Hospice & Community Care. The funds are comprised of member donations and monies raised by the golf outing.

Organization Support East Cocalico Lions Club

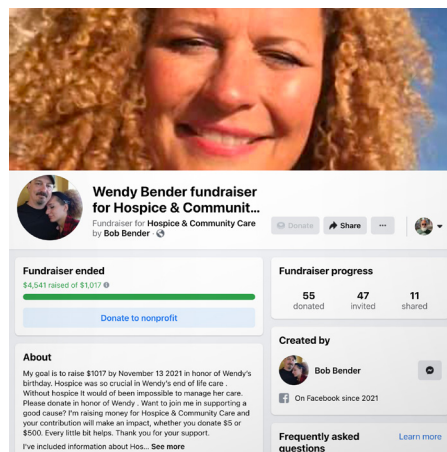


It was a brisk and windy November day, “which had a few fellow East Cocalico Lions Club members chasing money down the streets,” shared Lions Club member Bruce Carpenter. But even Mother Nature could not halt the East Cocalico Lions Club from holding their annual Toll Road Collection which benefits four local organizations, that includes Hospice & Community Care, on “Black” Friday. “Our Lions Club members asked a small toll or donation from all cars, trucks, motorcycles, and buggies that passed through the square in Reamstown,” shared Bruce. “Thanks to the generosity of the community and all of the drivers, we received coins, bills, and even checks totaling a record-breaking amount of more than \$5,000.” One hundred percent of what was collected, along with a donation from the East Cocalico Lions Club, was divided and distributed evenly between four local nonprofit organizations.

The East Cocalico Lions Club has been supporting Hospice & Community Care since 1998 through its Toll Road event. At that time, there were several Lions Club members or their family members who were being cared for by Hospice & Community Care. “We appreciated the compassionate care that they received from Hospice and felt it would be a great organization to support,” commented Bruce.

Facebook Fundraisers Bob and Wendy Bender

In 2020, Wendy Bender and her family were cared for by Hospice & Community Care. “Hospice was so crucial in Wendy’s end-of-life care,” shared Bob Bender, Wendy’s husband. “Without Hospice it would have been impossible to manage her



care.” Wendy received hospice care at home and at the Bob Fryer & Family Inpatient Center.

To honor Wendy and to give back to others, Bob created a Facebook Fundraiser with 100% of the proceeds

benefiting Hospice & Community Care patients and families. Bob set a goal of raising \$1,017 by November 13, 2021 in honor of Wendy’s birthday. By August 2021, Bob had already met and exceeded his goal—raising \$6,384.

“Wendy’s love for everyone made it possible,” shared Bob. “She was selfless. Even while on her cancer journey, she would put others first. Wendy made such an impact on the lives of everyone she met and the Facebook fundraiser was a way to pay it forward.” Friends, family, former classmates of Bob and Wendy, as well as customers at Bob’s small business donated in Wendy’s honor.

Developing Staff to Enhance Patient Care and Comfort

Hospice & Community Care's 400 employees go above and beyond each day for our patients and families. All Hospice team members, regardless of their roles and disciplines, make a significant impact in the lives of patients and their families. In each edition of *Horizons*, you will meet a team member who is living out our mission as we shine a spotlight on these individuals.

The conversation lasted all but ten minutes, but it made such an impact on the patient and family. "We were caring for a 33-year-old patient who was being cared for by her husband and two teenage daughters," shared Paige Payne, Vice President, Patient Care, Hospice & Community Care. "The family had a strong faith, being open and honest with one another about the terminal diagnosis, and I discovered that they had not yet made pre-arrangements for a funeral. I encouraged the family to make plans together so that the patient could make her wishes known. The next time that I visited with the family, the husband proudly reported back to me that he, his wife and daughters had made all of the funeral preparations and had reached out to a funeral home."

"When we do something to help further what is important to a patient and family and are able to see them take our guidance and insight and make it their own, it is so rewarding," shared Paige. "When you take care of a patient there is an immediate connection. For me, the moments that I cherish are when we are able to make the patient and their caregiver's experiences together meaningful."

Paige is using that passion for helping others in her new role as Hospice &

Community Care's Vice President, Patient Care. She assumed her new position in September 2021. Paige has 36 years of experience in the hospice field and has been with Hospice & Community Care for nine years as the Director of Home Hospice in York.

"My grandfather died during my adolescence and that was a pivotal moment for me," commented Paige. "He was my father figure. His cancer treatment and, ultimate death, impacted me. When I went to college, I was fascinated with death and dying and took a class on the subject." At that time, the hospice

President's Letter
